# • Application Form and Fee

Grace Lutheran School tuition for the 2017/2018 school year is \$6,809 for grades three through eight. Also there is a registration and processing fee of \$500 for all students who are attending from other countries.

The cost for books is \$57. Additional small charges may be incurred during the school year for special off campus activities, i.e. field trips, as they occur.

## • Recommendations

Information from at least two school staff members will be used for admissions and placement decisions. Recommendations from an agent will be used to determine grade placement.

## • Transcript

A transcript of your courses, credits, and grades from the past year is very important to our review process. Please request that a copy (In English) is sent with your application. The enclosed **Request for Release of School Records** may be used for this purpose. Parents must sign the form and submit it to the school.

## Visa Transfer

Transfer students need to transfer visa status from your current school to GLS. Use the form **F-1 Student SEVIS Transfer Form.** 

#### • Liability Release

GLS assumes no liability for loss, damage, or injury caused by students who participate in programs at our school. Parents must sign and return the **Liability Release and Consent Form** to GLS.

#### • Temporary Guardianship

Authority must be given to your child's temporary U.S. guardian. Parents should fill out and sign the form **Appointment of Temporary Guardian for Minor Children** and the information worksheet that will be given to your child's temporary guardian.

#### • Medical Emergency

Parents must fill out and sign the **Medical Emergency Authorization Form.** Proof of medical insurance must be recorded on the form. If your child has no medical insurance, you will be required to purchase insurance through a U.S. medical insurance company. This information will be provided upon request. The **Medical Consent/Release Form** must also be filled out and signed, authorizing GLS and/or guardians to act on your behalf in case of medical emergency.
